One issue was to order the replacement Crape Myrtles and a motion was made by Nic Foster, seconded by Tom Ruddy and unanimously carried to accept the proposal for the installation of seven crape myrtle trees for \$2123.00. this price includes the removal and disposal of ginger where necessary.

#### Committee Reports:

#### **ARB Committee:**

The ARB had one application for 1550 Woodstream to keep a POD in the driveway temporarily. This was approved and all appropriate letters sent.

**Common Grounds Committee**: Presented additional proposals for plantings around the ponds where there is erosion. No action at this time. Also noted, both entrances will be looked at for plantings and also Cutrite has started thinning out the palmettos.

Finance Committee: There was nothing to report.

Maintenance/Safety Committee: Pool bathrooms were completed, small pond fountain completed. Contracted with Oneill's tree service for additional tree work, Poles and electrical covers were discussed and TECO will only replace them once they are damaged. Cutrite fixed the well pump controller. Several irrigation leaks were repaired. Bruce Berger has asked residents to advise when they see the covers to the electrical boxes and/or cable boxes to advise M&A.

**Pool Committee:** The committee presented a chart to show the stennar pumps, chlorinators, well tanks, filters and heaters for both the pool and spa. They have a log book with parts and dates of install. The new pool company has indicated that the regulator for the spa should be added and will cost approximately \$1,500.00. The chlorinator flow valve is broken and needs to be replaced. The cost for this is approximately \$45.00. The pool committee has the authority to spend the money on this replacement. Monkey Rocks commenced work on July 7, 2017.

**Welcome Committee**: The welcome committee welcomed one new owner. The letter has been revised, but not implemented yet.

## New Business:

Cross Creek executed the contract addendum for Management & Associates regarding Estoppels. This was a requirement with the law that changed effective July 1, 2017.
