#### Finance Committee

## Maintenance/Safety Committee

Maintenance and Safety committee is responsible for identifying hazards to the safety and wellbeing of the community and reporting issues to the homeowner or Management and Associates.

#### **Pool Committee**

The Pool Committee's main purpose is to ensure that the community pool is being maintained. The Pool Committee will review the state of the pool and community rules governing its use and make recommendations to the Board regarding changes in rules of use" for the pool (hours of use, etc.)

#### Social Committee

The Social Committee is responsible for organizing and communicating any social events that occur within the Cross Creek community to which all Cross Creek homeowners are invited.

# **Welcoming Committee**

The Welcoming Committee greets new residents and gives them information about Cross Creek and how to seek additional information about the area and community.
