1. Article II, Restrictions, of the Declaration shall be amended to add an entirely new Section 2.26, Leasing, to read as follows:

Section 2.26 - Leasing

Section 15. A Lot Owner shall not be authorized to lease or rent their Lot during the initial eighteen (18) months of ownership. This provision shall not apply to the Association in cases where the Association takes title to a property pursuant to foreclosure or a deed in lieu thereof. All leases shall be for a minimum term of six (6) months and no more than one (1) lease shall be permitted in any given twelve (12) month period.
